Dear Mr. Marks:

I am writing this to correct an error that I made in looking over your application for graduate studies at Purdue University. When I signed the acceptance I evidently had in mind that you were wanting to work toward the Master of Science degree, even though you had clearly indicated that you would already have the MS degree and hence would be working toward the Ph.D.

Our policy is to admit students to the Ph.D. program only if they have an index of 5.2/6.0 (3.2/4.0) in their MS program. Your index was 4.5/6.0 for your undergraduate work and your graduate school index was 4.76/6.0. I must therefore inform you that we must withdraw our permission for you to work toward the Ph.D. degree in Electrical Engineering at Purdue University.

I regret very much, having made this mistake, but with an index as low as yours it would be virtually impossible for you to earn the Ph.D. degree. Neither would we be able to give you any sort of financial aid.

I hope that this is not too big a disappointment to you, but I feel that you would be wise to give up any future plans for earning the Ph.D. degree.
